- Mike Daly welcomed the Steering Team and provided an update on the establishment of the Faculty Advisory Group.
  - The Faculty Advisory group is comprised of representatives from the six state universities.
  - Jolanna Kord asked if members of the group will adjust if faculty council members change at universities.
    - Mike will work with Sam Christy-Dangermond to manage the composition of the group as change occurs.
- Mike provided an update regarding previous meetings rpk held with key stakeholder groups since the last Steering Team meeting.
- Mike shared the progress in aligning and defining terms and definitions between rpk, KBOR, and the institutions for the Academic Portfolio Review.
- Mike explained the data supporting the Academic Portfolio Review will be shared with rpk by KBOR.
- Mike shared that for the Workload Review, universities will be asked to collect additional data.
  - Jill Arensdorf requested rpk inform the Steering Team of these requests to ensure the appropriate individuals on the campus are aware of the requests outside of the Data Team.
    - Mike confirmed that rpk will provide the Steering Team updates regarding additional data requests.
  - Jill Arensdorf asked Daniel Archer if the recommendations from rpk will impact the next annual program review cycle.
    - Daniel Archer stated that KBOR is engaged in discussions regarding the immediate future of the KBOR academic program review and will share a final determination soon.
- Jill asked for increased information regarding the Data Team's meetings be made available to the Steering Team.
  - o rpk and KBOR will update the KBOR project website with the dates for future Data Team meetings as well as the current Data Team membership.

- Katie added that the Data Team is preparing to review four data templates and that rpk will provide each university technical assistance with their data template.
  - Shirley Lefever inquired if the Steering Team could review the data templates to ensure the process is mindful of institutional mission.
    - Katie stated that mission has been central to discussions with the Data Team and that rpk will request the Data Team collaborate with their Steering Team counterparts regarding any clarifications needed to the data templates to better account for institutional mission.
- Barb Bichelmeyer requested rpk and KBOR consider rescheduling the next Steering Team meeting for July 1 due to the holiday.
  - o rpk will work with KBOR on an alternative date for the next Steering Team meeting.

- The Data Team will review and provide feedback on course and faculty data templates.

- rpk will work with KBOR to determine an alternative date for the next Steering Team meeting scheduled for July 1, 2022.
